

While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. GCI Select Equity was rated against the following numbers of Large Blend funds over the following time periods: 570 in category during prior 3-year period funds in the last three years.
